IMPORTANT: PRIOR TO SIGNING, PLEASE READ THE RULES AND REGULATIONS OF HEI LISTED BELOW. THESE RULES AND REGULATIONS ESTABLISH THE TERMS AND CONDITIONS OF THE PRIVILEGES GRANTED BY HEI. IF YOU DISAGREE WITH, OR BELIEVE YOU WILL NOT BE ABLE TO ABIDE BY THE FOLLOWING RULES AND REGULATIONS, DO NOT APPLY FOR STABLING.

IN CONSIDERATION of being allowed any stabling accommodation on the premises of HASTINGS ENTERTAINMENT INCORPORATED, I AGREE:

1. That I have been provided with and have read and fully understand the Rules and Regulations of Hastings Entertainment Inc. including:
 - a. That, from February 1, 2010 to October 22, 2010, each stall shall be assessed a \$7 per day facilities rental charge billed (and/or pro-rated) monthly.
 - b. That for 2010, Hastings Entertainment Inc. will require horsemen participating at the meeting to abide by an 'Enter to Run' policy. This policy eliminates the opportunity to scratch from the body of the race except due to sickness or unsoundness, which must be both diagnosed and certified by a licensed Veterinarian. Further entry of the horse will not be accepted by the racing office for a period of seven (7) days inclusive of the date of scratch. SEE GROUND RULES and CONDITION BOOK for full policy.
 - c. Upon arrival to the Hastings Grounds all horses in my care shall be properly vaccinated. This includes CURRENT (January 15, 2010) vaccinations for Flu, Rhino, and Strangles. Vaccinations must be signed off by a licensed veterinarian. No horse will be allowed on the grounds without this certification. Certification forms will be made available online, in the racing office, or by fax. These forms must precede or accompany each horse prior to arrival. In addition, proof is required of continued vaccinations for Flu and Rhino for all horses under the trainers' care by April 1, 2010 and July 1, 2010.
2. That I have received and executed an Application for Access Rights in favour of Hastings Entertainment Inc. and agree to be bound thereby.
3. That this Contract is made with and shall enure to the benefit of Hastings Entertainment Inc.

I, the Applicant herein, confirm that I have read all conditions contained in this Application and fully understand the conditions set out in this Application and by accepting stabling permanent or temporary on the Hastings Grounds fully agree to these rules as represented by my signature.
