AN ALLOWANCE STAKES FOR ALL NOMINATED THREE-and FOUR YEAR-OLD FILLIES WHICH PASSED THROUGH THE 2021 & 2020 CTHS (BC DIVISION) YEARLING & MIXED SALE, AND ALL THREE-and FOUR YEAR-OLD FILLIES THAT PASSED THROUGH THE 2022 CTHS (BC DIVISION) HORSES OF RACING AGE SALE AND ALL CANADIAN BRED FILLIES THAT PASSED THROUGH THE 2021 & 2020 CTHS (ALBERTA DIVISION) SALE, OR CTHS (MANITOBA DIVISION) SALE OR CTHS (ONTARIO DIVISION) SALE WHERE THE FULL COMMISSION, NOMINATION FEES, AND SUSTAINING FEES HAVE BEEN PAID. For the CTHS BC Sales Graduates, the three-year-olds must have made sustaining payments on (February 14, 2022) and four-year-olds must have made sustaining payments on (February 14, 2021) and (February 14, 2022) to be eligible for the 2023 sales stakes. To remain eligible a further sustaining fee of \$200 is due no later than Tuesday, February 14, 2023 (three-year-old or four-year-old). Additionally, a supplemental payment may be made in the amount of 5% of the purse amount together with all outstanding and unpaid nomination payments, and/or sustaining fees. This payment must be paid in full to the CTHS (BC DIVISION) no later than Wednesday, August 16, 2023 at the time of entry.

HASTINGS' final nomination and payment of \$100 is due by Saturday, August 12, 2023. CTHS AB, CTHS MB and CTHS ON Sale graduates will pay \$750 to nominate by Saturday, August 12, 2023. Entry fees will be refunded to any horse that fails to draw into the race due to preference requirements. With \$50,000 guaranteed of which 55% goes to the winner, 20% to second, 10% to third, 5% to fourth and 4% to fifth and 2% sixth through eighth. Preference will be based upon the rules outlined in the condition book at the time of entry. Weight: Three-Year-Olds 120 lbs.; Four-Year-Olds 123 lbs. Non-winners of \$27,500 once allowed 3 lbs. Non-winners of \$12,000 once allowed 5 lbs. Non-winners of \$8,000 once allowed 7 lbs. Field limited to 12 starters. In the event that races are oversubscribed, preference will be given to horses that passed through the sale in the jurisdiction in which the Sales Stakes is being held. For example, CTHS BC sales graduates will have preference for the Sales Stakes races in BC.
